Booth Sharing: All sharing artists must apply individually and be accepted into the Festival. It is your responsibility to identify and confirm a sharing artist. See the fees for sharing above.

NOTE: Youth artists, age 17 and younger, may sell and share a booth with a Juried Booth mentor. Youth artists do not pay an application fee or booth fee; however, before Festival day, we must have the name of the Youth Artists, their CIB and three images of their work.

1. \$35 Application Fee is non-refundable
2. If the festival is cancelled because of wind or weather, NO refunds, NO rollovers will be issued.
3. There will be a \$20 cancellation fee for all cancellations below
 - a. By May 1, booth fees are refundable
 - b. May 15 to June 1, 50% refundable
 - c. June 1 to market, no refund
